1	Mr. Deepthi Lokuarachchi (GCEO) explained that the scope of this tender should be as Design, Installation, Implementation, commissioning and Maintenance of the System including development of operational acceptance testing and system integration with third party solutions and connectivity to existing resources.	
2	Data Migration: Data migration will be arranged by the LHC in collaboration with our current supplier. This includes a data migration component that must transfer administrative data, such as patient demographic data, master data, and all other opening balances, including inventory and outstanding amounts. It does not involve migrating the entire database.	
3	Incumbent Vendors: This is a completely new project, and incumbent vendors are not part of this project.	
4	Third party authorization / registration: Third party applications to be integrated with the HIS system. Eg. Insurance and Admission	
5	Branches which are covered under this HIS: This project covers the hospital. Does not include the laboratories. Laboratories have separate systems and only integration part have to be done.	
6	Double Occupancy: Explained about the two scenarios. In one instance - Sometimes patients go for theSometimes, patients go to the OT and are temporarily placed in another bed (e.g., ICU). Both the ICU bedand the patient room are detained, and the patient is charged for both.In another scenario, patients' attendants are assigned to one room and use the facilities, but the patientis in another room. Consequently, both rooms are charged
